GRANTS ARE OFFERED THROUGHOUT THE YEAR TO SUPPORT LOCALLY INITIATED PUBLIC HUMANITIES PROGRAMS THAT PROMOTE REFLECTION, DIALOGUE, AND CIVIC PARTICIPATION.
